

Waiver Agreement for Denver Inside and Out LLC

I understand and acknowledge that I am legally agreeing to the statements in the following paragraphs of this Waiver Agreement by signing my name below and that these statements are being accepted by Denver Inside and Out, LLC in consideration for allowing me to participate in this event. I further understand and acknowledge that my statements are being used by the event organizers, administrators, employees, sponsors and other parties defined as the "Released Parties" as true and accurate statements.

1. I hereby represent that I am in good health and in proper physical condition to participate in this Event and I am not under the influence of alcohol or any illicit or prescription drugs which would impair my ability to safely participate in this event. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in this event. I am responsible for my own safety and well being at all times and under all circumstances while participating in this event.
2. I understand, acknowledge and assume all of the risks and dangers associated with participation in this event which will take place in a downtown metro city environment. These dangers include without limitations, the potential for serious bodily injury, permanent disability, paralysis and loss of life, damage to property, contact with other participants, animals or other natural or manmade objects; dangers from adverse weather conditions and surface hazards, inadequate safety measures, situations beyond the immediate control of the event organizers and other undefined, not readily foreseeable and presently unknown risks and dangers. I understand that these risks may be caused in whole or in part by my own actions or inactions, the actions or inactions of others participating in the event or the negligent acts of the released parties defined below. I hereby expressly assume all such Risks and responsible for any damages, liabilities, losses or expenses which I incur as a result of my participation in this event.
3. On behalf of myself, my executors, administrators, heirs next of kin, successors and assigns and anyone else who might sue on my behalf, I HEREBY WAIVE, RELEASE and FOREVER DISCHARGE DENVER INSIDE AND OUT, LLC , all event sponsors, event producers, event staff, administrators, officials contractors, vendors and organizers (including event directors), volunteers and other persons or entities involved with this event, states, cities, other participants and representatives of all of the above (collectively, the "Released Parties") from any and all claims, causes of action damages, losses (economic and non-economic, and liabilities of every kind (collectively "Claims")) for death personal injury or property damage which may arise out of, result from, or relate to my participation in this event.
4. I further COVENANT and AGREE NOT TO SUE any of the released parties for any of the claims that I have waived, released, or discharged herein. I AGREE TO INDEMNIFY and HOLD HARMLESS the released parties from any and all expenses incurred, claims made or liabilities assessed against them, including but not limited to attorneys' fees and litigation expenses, arising out of or resulting from, directly or indirectly, in whole or in part, my breach of failure to abide by any part of this waiver agreement and my actions or inactions which cause injury or damage to any other person.
5. The parent or legal guardian, who signs the Waiver Agreement on behalf of a minor, hereby acknowledges that he or she has the legal capacity and authority to act on behalf of Said person to legally bind Said Person to the waiver Agreement. The parent or legal guardian who signs the Waiver Agreement agrees to indemnify and hold harmless the Related Parties for any expense incurred, Claims made, or liabilities assessed against them, as a result of any insufficiency of legal capacity or authority to act on behalf of Said Person in the execution of the Waive Agreement.
6. I grant my permission to all of the foregoing to use photographs, motion pictures, recording or any other record of my participation in the event for any legitimate purpose without compensation.
